President report / JMR quarry report (Tim):

- Installed new compressor at JMR 5 members and Buddy McKinney (board member) did the work. Hurl Holloway (member) is in charge of moving aerators if needed.
- Treasure Hunt coming up.
- Gate has been moved.
- Tim Stafford and Mick Wrenn met with the military training people.
- Mick will check the deed to see what the wording says about the right of way. There is a question about the right of way and whether it is a public right of way or a land owner/member right of way. If it is public then we cannot hold anyone accountable for trespassing.

#### American Quarry (Devan):

- Aerators are working well
- The family (Ted Hanna) that lives next to the American quarry was always allowed to fish as that was part of the original sale. We need to look at whether they are bound by the rules of the members of the PDRA. Since the paddlefish are federally protected, it may be necessary to update the Hanna's on the PDRA rules.
- Deven is working on the deck and walkway.
- Barry is going to bring the tractor back to American for some work.

#### Old business:

- Dues increase Need to Finalize wording to present to membership. Add to Facebook, email, website and send postcards. Mark to get quote on sending ~700 postcards in order to notify the membership of the general assembly meeting.
- Tim will finalize the maps with the new district lines. Devan will get a poster printed for the building at American.
- There is a question on memorials as far as who gets their name on the rock. Lifetime members and founders go on front side. Family members can purchase a plaque for the back of the rock at American. Does anyone know what the costs is?

#### New business:

All board members and leadership agree that no monies (other than perhaps \$600 should be paid to the current contractor).
- Fishing There was discussion about the fishing at Lake Norman and Tim Klima offered to put up game cameras.
- Incident at LKN Barry provided details on an incident with a guest of Sun's Up Scuba and a
  neighbor of the quarry. Tim Stafford read an email from the man's daughter. The board
  discussed and concluded that the person is not allowed back on PDRA property and that if he
  tries to join, his membership will be declined. The person's name is David Kuss.
- General Assembly meeting A 60 day notice is required to membership due to items that need to be voted on and due to the special date of September 26, 2021. 30 notice for absentee ballots. Items to be voted on are the membership increase, district lines, and any leadership or board member changes. Also need to find out what positions are up for re-election.

Michelle, here are the numbers as we stand,

Pipe 3723.60

initial labor and rental price 7000.00 to include 2000.00 for rentals.

Additional cost;

mini x to cross Charlies yard 600.00

Additional days of compressor, mole etc, 570.00

4 days additional labor at 1500.00/day Thurs, Friday, Sat and Sun. 6000.00

17893.60

Direct Drill verbal quote today was 5000.00 if they can just use the existing 4" hole i bored and pull back the pipe.

additional 1000.00-4000.00 if the pull back is more than 2 hours.

Also need an additional 6000#mini to rent from Sunbelt to cross Charlies yard again to fill open hole and move large bolders back up the hill.

I meet the direct drill guys at 10am tomorrow. They are working in mooresville the hope is to get them on the job ASAP so we don't loose the existing hole bored now.

On April 1, 2021 you were contacted about installing a larger pipe at Lake Norman Quarry because the one inch pipe that you installed in the fall of 2020, was working too slowly. On June 2, 2021 you contacted us saying that you had found a 3 inch pipe for the work at Lake Norman Quarry, 350 Greenbay Road, Mooresville, NC.

In discussing this project, board members familiar with this quarry, suggested that a 5 or 6 inch hole be drilled to run the pipe. This was not a requirement, but a suggestion, as it was not utilized. The PDRA relied on your expertise in selecting the method and sizing for the hole and pipe.

You submitted a quote to install the pipe via email on June 2, 2021. The quote indicated the you would purchase the 3" pipe (approx. 1000 ft length) and would install the pipe. The quote was broken down into 2 sections. The first section for the cost of the pipe (1000 feet of 3" CTS flex pipe) \$3500. The Second section for the cost to install the pipe (trencher, core bore, excavator, mobility, and labor) \$7000. There is no mention of a length of time to install the pipe.

Your quote was submitted to the PDRA (Piedmont Dive and Rescue) Board of Directors. It was discussed and a vote was taken to allocate \$10,000 for the costs associated with the purchase and installation of the pipe. No time requirements were given on the quote other than in a text where you indicated it would take at least two days with payment at completion.

On June 28 you began work at Lake Norman Quarry. On Saturday, July 3, a small excavator was needed to move large boulders on the neighbor's property as a large excavator would have done damage to his property. We were told that the rental was \$600 and a board member approved the PDRA paying the additional rental fee for the excavator as an extension of the work.

On July 6 you emailed and indicated that you have made attempts to pull the pipe (3.75" OD) through the 4" hole with no success. You have submitted a bill for \$17,893 and said that you cannot complete the job without bringing on another company for an additional fee (\$5000-\$9000). You have indicated that this company would drill a 6" hole and pull the pipe through.

The PDRA treasurer have mailed a Check for \$3,723.60 to cover the cost of the pipe as it has been delivered to the quarry.

You have done work at the quarry previously, which is why you were contacted for this work. You were aware of the job site, neighbor, and the fact that the location is a rock quarry. Unlike the first job, where the price was \$1500 a day on an exploratory basis to see if there was a culvert on the quarry side of the road, this job was not exploratory.

If you were only willing to provide 2 days of labor, that was never specified on the quote. You continued to work past the two days without any mention of cost overruns until way past the two days. No stoppage of work or alternatives other than continue the current course of action was ever discussed.
